**Substance/mixture** : Mixture Contains: Lozenges containing small amounts of antiseptic ingredients (Amylmetacresol 0.6mg / lozenge and 2,4-Dichlorobenzyl alcohol 1.2mg / lozenge) , local anaesthetic (Lignocaine Hydrochloride 10mg / lozenge] flavourings, colours, propylene glycol (3017723 only) and weak acid in a Sucrose/ Glucose Syrup lozenge base.
