**Substance/mixture** : Mixture Contains: Lozenges containing small amounts of antiseptic ingredients (Amylmetacresol 0.6mg / lozenge and 2,4-Dichlorobenzyl alcohol 1.2mg / lozenge) , flavourings, colours and weak acid in an Isomalt / maltitol syrup base.

### Description of necessary first aid measures
